Call to Order

Chairman Mills called the meeting to order at 5:36 p.m. and welcomed all members and guests.

Chairman Mills solicited public comments from the floor and requested comments to be limited to 3 minutes per speaker. No public comments. The meeting agenda was reviewed. No changes were made to the agenda.

Link Transit/System Update

Chairman Mills asked about the electric bus procurement.

Ms. Williamson asked about the seating capacity.

Chairman Mills asked about what bus shelters are being considered and popular bus stops. Mr. Andoh stated he will share that list with the PTAC.

Mr. Harrison stated he is appreciative of the bus shelter in Gibsonville and talked about the challenges with the railroad.

Mr. Carter suggested that a restroom is needed at the downtown facility.

Chairman Mills asked about encroachment issues and process to construct bus shelters in the service area.

Mr. Andoh answered those questions.

Link Transit Operations Report

Mr. Andoh explained that was presented in the last item.

Ms. Brown asked about hiring bus operators.

Mr. Andoh discussed the wage increase and hiring more bus operators as a result.

Mr. Andoh showed a sample of a Simmie Seat that can be attached to a bus stop pole.

Mr. Harrison stated he would like to see these seats at every bus stop.

Chairman Mills asked if the pole is powered coated. Mr. Andoh stated yes.

Ms. Brown asked if the seats can be raised for seniors. Mr. Andoh stated yes.

Ms. Williamson stated this can increase visibility of the transit system.


Other Business

Ms. Williamson asked how long will the fare free last. Mr. Andoh stated indefinitely.


Adjournment
