Call to Order

Secretary Corbett called the meeting to order at 5:10 PM and welcomed all members and guests.

Secretary Corbett solicited public comments from the floor and requested comments to be limited to three (3) minutes per speaker. No public comments. The meeting agenda was reviewed. No changes were made to the agenda.

Approval of the June 19, 2023, Meeting Minutes

The June 19, 2023 meeting minutes were reviewed. Mr. Meisenbach made a motion to approve the meeting minutes. Mr. Mathewson seconded the motion. All PTAC members voted in approval of the June 19, 2023 meeting minutes.

Discuss Meeting Time for PTAC

Mr. Andoh presented a summary of this item and mentioned that a request was made by Commissioner Carter to look at alternative dates so he can be in attendance. Commissioner Carter suggested 2nd Tuesday at 5 p.m. Mr. Andoh stated he could make this time change

work; however, if the meeting extended past 6 p.m., he would have to depart and conduct the meeting remotely. The Commission discussed this matter briefly and Mr. Meisenbach made a motion, seconded by Mr. Carter. All PTAC members voted in approval of the 2nd Tuesday of the month at 5:00 p.m. as the meeting time, generally every other month (January, March, May, July, September, November). Mr. Andoh stated a meeting will be scheduled for November to realign the schedule.

Link Transit/System Update

Mr. Andoh provided the following to the PTAC regarding Link Transit services. Regarding the bus procurement, he mentioned that the BYD buses are in service and are running well. He mentioned that the bus procurement plan changed and was discussed with City Council in July has changed due to issues with ARBOC obtaining chassis. The purchase order for the five replacement vehicles was cancelled and issued to Gillig for five 29 foot buses and to ABC Bus for three low floor paratransit vehicles. The commissioners asked questions regarding electric bus range, capacity and funding for the change in vehicles to which Mr. Andoh answered. Regarding the fare implementation, Mr. Andoh summarized the new fare structure approved by City Council after a public hearing and mentioned the effective date would be December 18, 2023. He further explained that the processes to set up fare collection are underway. Mr. Murphy asked if paratransit fare was \$2.00. Mr. Andoh said no, it's the same as fixed route as he originally suggested. Mr. Andoh went on to discuss the bus shelter project and that five bus shelters have been installed. Mr. Doward asked about bus passengers going to ACC without a destination. Mr. Johnson of Transdev discussed what was occurring with that matter. Mr. Doward suggested an additional bus stop be added before ACC. Ms. Bullock proposed a location to which will be evaluated to see if that can be implemented. A suggestion was also asked about a bus stop closer to the Burlington Senior Center which will need sidewalks and better accessibility. Mr. Andoh stated he will investigate it. A general discussion continued this matter including adding a trash can at the bus stop in Graham at the courthouse on Elm Street as well as details on boardings at bus stops. Mr. Andoh mentioned he can provide that data at the next meeting as that data is used to determine where to place bus shelters. Mr. Andoh continued to discuss the Transit Development Plan and Transit Facility Study and that Kimley-Horn is on board and is starting the effort of the plan, including information gathering and public outreach. Mr. Andoh continued to discuss the Regional Transit Study being conducted by the MPO and that they are looking at route concepts and governance structure. Ms. Mallette said a few words about the project status. Mr. Andoh had Mr. Johnson provide the commission with an update about Transdev and its operations the past month. Mr. Johnson did a presentation and made mention that paratransit demand is growing and that additional paratransit vehicles may be needed, to which Mr. Andoh stated that he is looking into the matter.

Link Transit Operations Report

Mr. Andoh presented the ridership update through September 2023 and discussed the performance of each route.

Other Business

Mr. Mathewson asked about the affordability of fares, to which Mr. Andoh answered. He also asked if notification could start 45 days in advance. Mr. Andoh said he didn't see why not.

Adjournment

Mr. Murphy made a motion to adjourn the meeting and Mr. Meisenbach seconded the motion. All PTAC members voted in approval. Secretary Corbett adjourned the PTAC meeting at 6:10 P.M.


